Reduce energy waste and save money with healthier, more sustainable schools.

The P-12 Schools: Green and Clean Energy Solutions Program provides funding for eligible pre-kindergarten through grade 12 (P-12) schools to reduce school energy use and assist in the transition to cleaner heating and cooling technologies.

Schools are eligible for up to \$250,000 for energy studies to reduce energy use as well as up to an additional \$250,000 to support the design of clean heating and cooling systems or net zero designs.* Schools are also eligible for direct incentives for projects that reduce energy use through eligible mechanical, equipment, and building envelope efficiency efforts.

Complimentary services

Schools participating in the program will receive complimentary services including free benchmarking and free clean heating and cooling screenings. Benchmarking serves as a tool to measure and track the impact of financial investments against energy use and greenhouse gas emissions, while screenings provide a free evaluation for investments in clean heating and cooling technologies including ground source heat pumps (GSHP), air source heat pumps (ASHP), and variable refrigerant flow (VRF) systems.

Eligibility

Schools may be public or private. Schools must be located in New York State and pay into the System Benefits Charge on their electric utility bill.



Apply district-wide

One application may be submitted for multiple buildings or projects across a single district.
